- ► 7-day average: 1,865 ↓ and 926 ↓ hospitalized
- ► Total vaccinated: One dose 57.6%; Fully vaccinated 54.9%
- ▶ DHS Update (<u>10.25.21</u>)
  - Boosters (J & J approved)
  - Children 5-11 (approval anticipated first week of November)
- EEOC Guidance on Religious Exemptions (National Law Review, 10.27.21)

#### Wisconsin Legislature

- SB 245/AB 185 Safe Harbor Bill passed out of Senate Committee but lost Republican votes
- Assembly floor session 10.26: workforce housing bills
- Moving out of Assembly committee today: CAN Leg Council Bills (AB <u>423</u>, <u>424</u>, <u>425</u>) subsidized guardianship payments (<u>AB 503</u>)
- Hearing today in <u>Senate Insurance</u>, <u>Licensing & Forestry</u>
  - ► AB 592/<u>SB 562</u> Medicaid for 12 months post partum
  - SB 657 removal of SUD specialty for master's level social workers
