Providers may include informational modifier 95 but are not required to do so.	Temporary
Forward <u>Health</u> <u>Update No.</u> <u>2020-13</u> 03/30/20	All providers, HMOs, and Other Managed Care Programs	Provides changes to Clinical Policy and Prior Authorization (PA), including allowing remote supervision, waiving requirements for face-to- face visits, and extending PA dates for an additional 90 days.	Temporary
Forward Health Update No. 2020-12 03/24/20	All providers, HMOs and MCOs, Community Recovery Services (CRS), Community Support Program (CSP), Comprehensive Community Services (CCS), Targeted Case Management Services, and Behavioral Treatment	Removes DQA telehealth certification requirements for mental health and substance abuse practitioners.	Permanent
		Clarifies that no restrictions on distant sites (provider location) exist for reimbursement for telehealth encounters.	Permanent
		Clarifies guidance re: federal enforcement of HIPAA.	Temporary
		Includes several provisions that apply specifically to behavioral health providers (mental health screenings, CCS, CSP, CRS, behavioral treatment services, and targeted case management).	Temporary
Forward <u>Health</u> Update No. 2020-09 03/18/20	All providers, HMOs and MCOs, FQHCs	Removes restrictions on originating sites (location of patient at time of telehealth encounter).	Permanent
		Expands allowable services to inpatient consults, inpatient prolonged services, e-visits, nursing facility service assessments, and telephone evaluation and management services.	Permanent
		Clarifies billing guidance for tribal and non-tribal FQHCs.	Permanent

<u>Alert 004</u> 3/23/20	Community Health Centers, Tribal Federally Qualified Health Centers, HMOs and Other Managed Care Programs	Clarifies billing guidance for tribal and non-tribal FQHCs.	Permanent
<u>Alert 002</u> 3/18/20	Home Health Agencies, Personal Care Agencies	Allows remote supervision for personal care services by registered nurses and provides timesheet guidance.	Temporary
